- . All entries must remain for public viewing until 7:30 p.m. If you must leave before this time, please designate someone to pick up your entry after 7:30 p.m.

### JUDGING:

Winner selection for each contest will be conducted by the staff of Sponsors, whose decisions are final and binding.

Each submission will be judged using the following criteria:

- (1) Originality (25%)
- (2) Use of Color (25%)
- (3) Technique (25%)
- (4) Quality (25%)

Winners and awarding of prizes will be announced during the Hoolaulea program.
